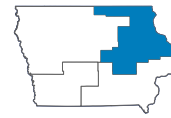

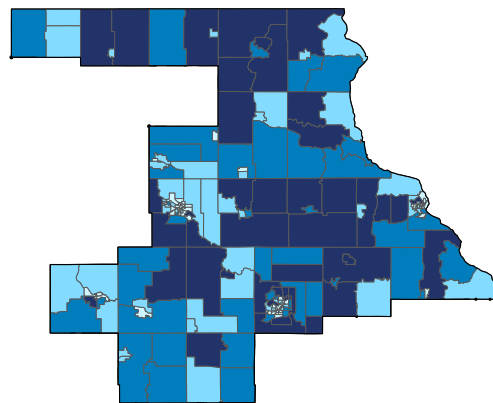
Iowa Congressional District 1



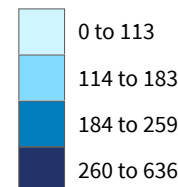

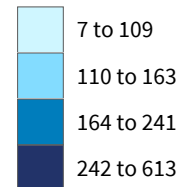

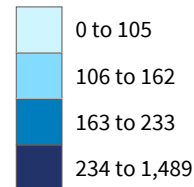

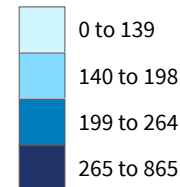
