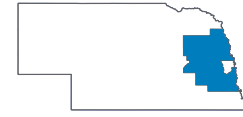

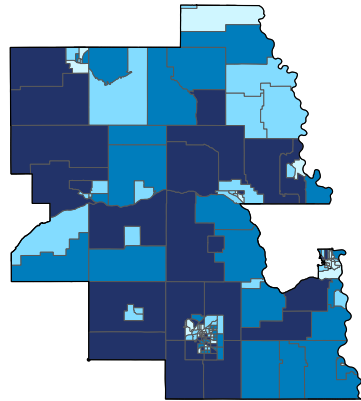
Nebraska Congressional District 1



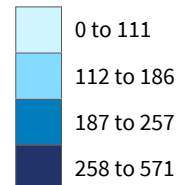

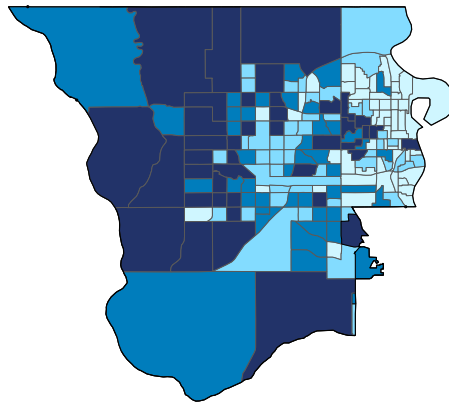

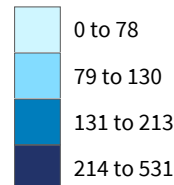

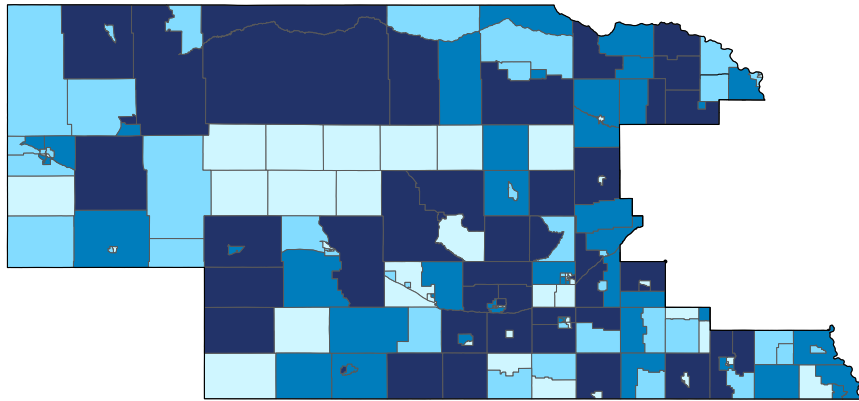

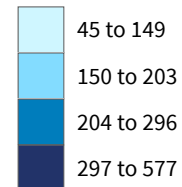
