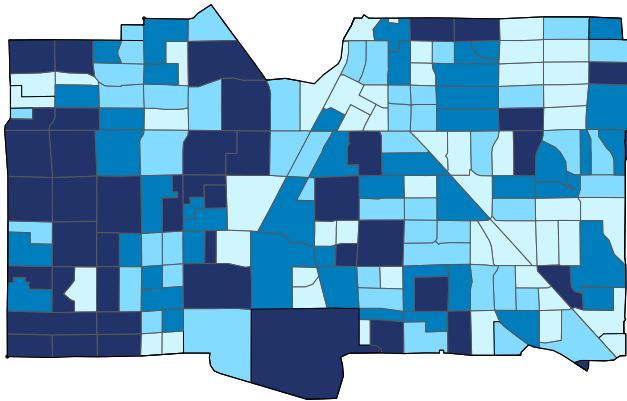
Nevada Congressional District 1



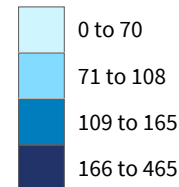

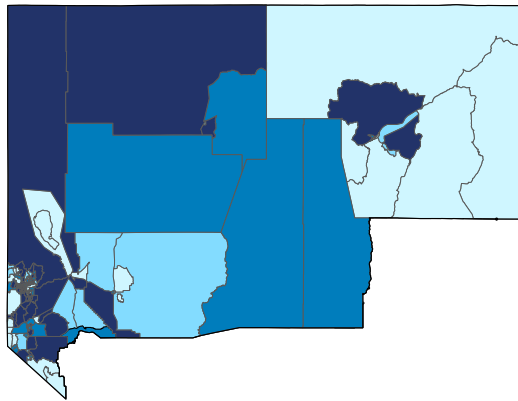
Nevada Congressional District 2



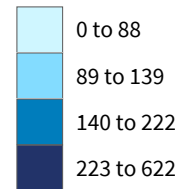

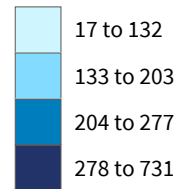

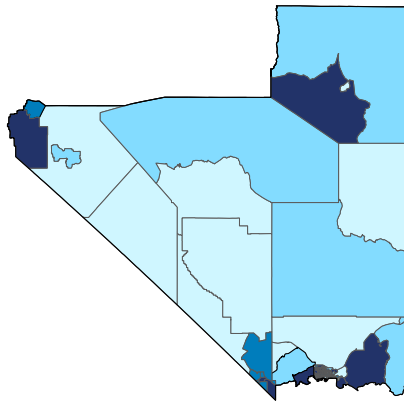
Nevada Congressional District 4



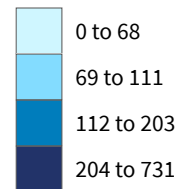
