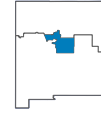

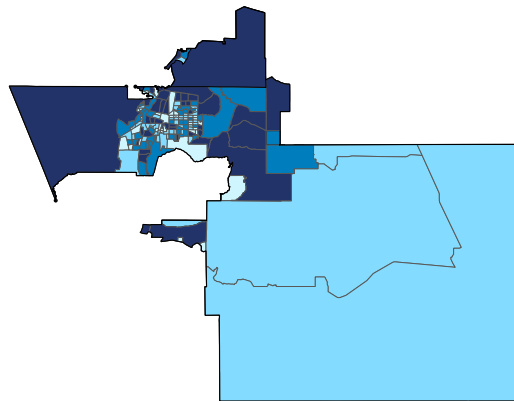
New Mexico Congressional District 1



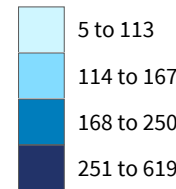

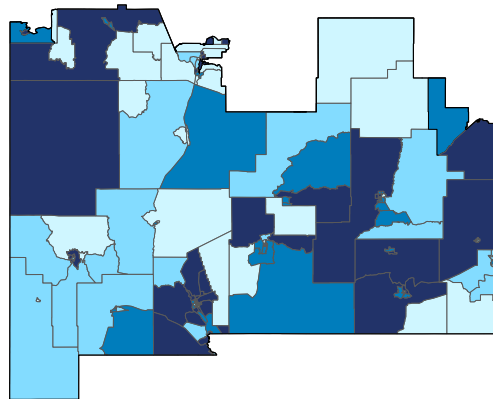
New Mexico Congressional District 2



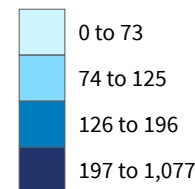

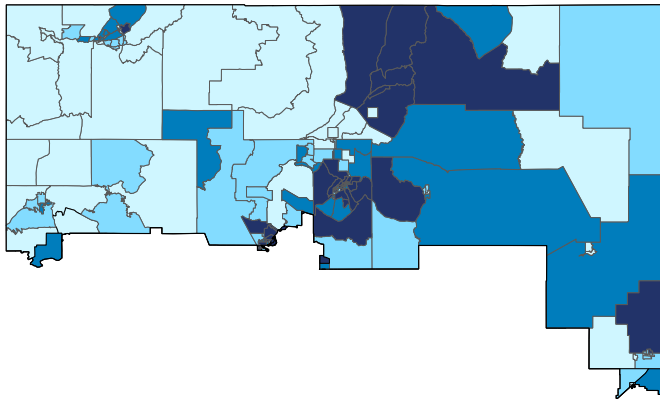

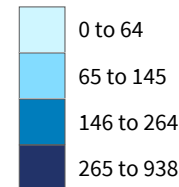
