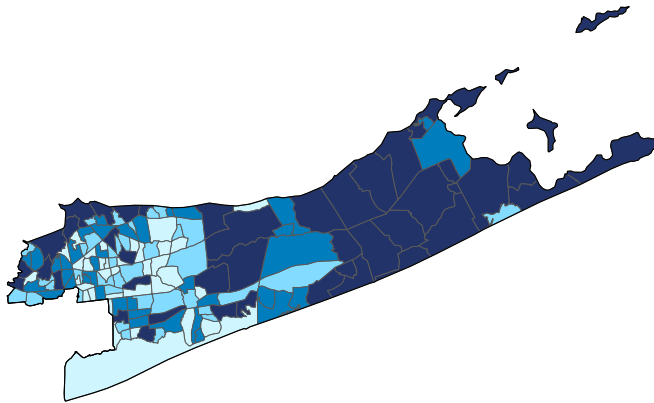

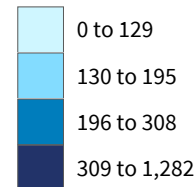

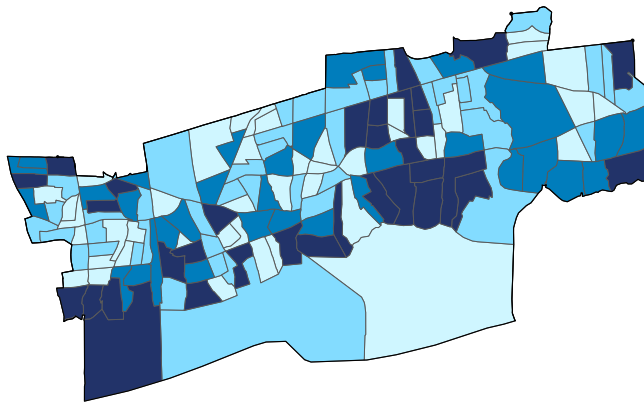
New York Congressional District 2



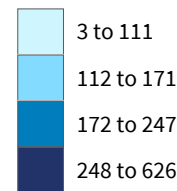

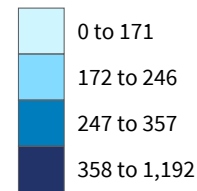

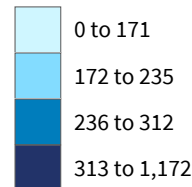

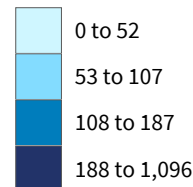

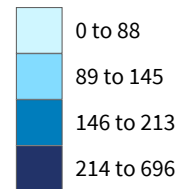

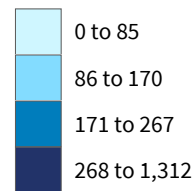

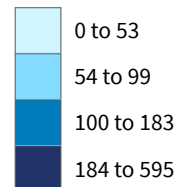

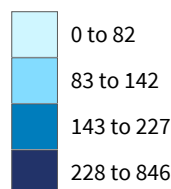

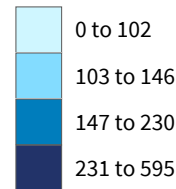

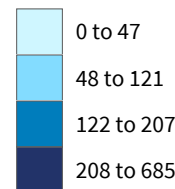

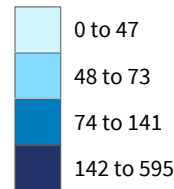
