

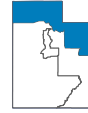

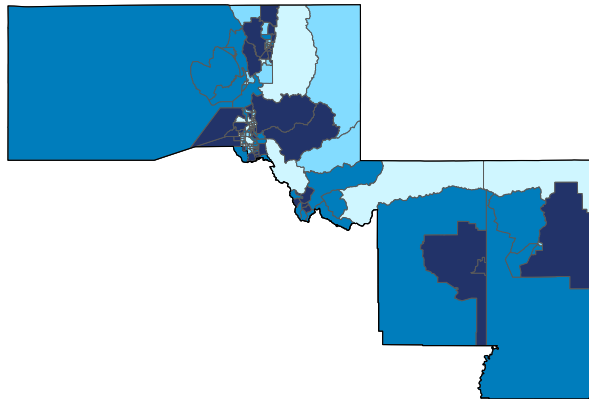
### Utah Congressional District 1



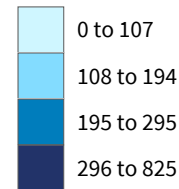

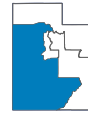

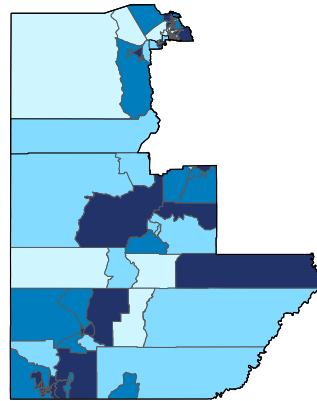
### Utah Congressional District 2



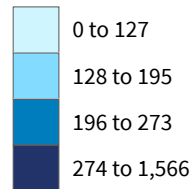

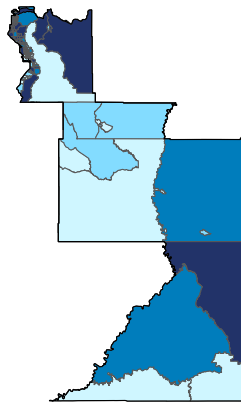

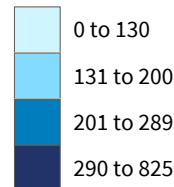

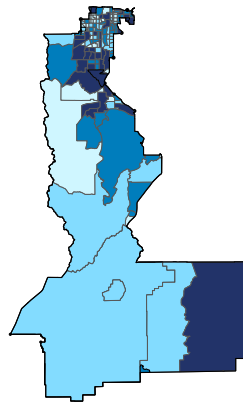

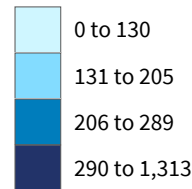
