


Establishments

Between March 2019 and March 2020, 11,238 Kentucky establishments opened and 10,509 closed, for a net increase of 729. Employment expanded at 23,248 and contracted at 24,683. Small businesses accounted for 11,104 openings and 10,340 closings.


Employment

Opening and expanding Kentucky establishments added 154,886 jobs, while closing and contracting establishments lost 154,578, for a net increase of 308 jobs. Small businesses gained 131,778 jobs and lost 129,920, for a net increase of 1,858 jobs.

Thousands of jobs



Small business loans

The Community Reinvestment Act requires large banks to report new small business loans. In 2019, reporting banks issued \$940.0 million in loans to Kentucky businesses with revenues of \$1 million or less. Total reported new lending to businesses through loans of \$100,000 or less was \$846.9 million, and total reported new lending to businesses through loans of \$1 million or less was \$2.6 billion.



Small business exports

A total of 4,688 identified firms exported goods worth \$31.5 billion from Kentucky in 2019. Of those exporters, 3,686—or 78.6 percent—were small. Small firms exported goods worth \$3.5 billion, making up 11.1 percent of exports by identified firms.


