

Establishments


Between March 2019 and March 2020, 5,208 Mississippi establishments opened and 5,456 closed, for a net decrease of 248. Employment expanded at 14,656 and contracted at 15,831. Small businesses accounted for 5,138 openings and 5,287 closings.

Employment


Opening and expanding Mississippi establishments added 86,591 jobs, while closing and contracting establishments lost 88,874, for a net decrease of 2,283 jobs. Small businesses gained 77,795 jobs and lost 75,220, for a net increase of 2,575 jobs.



Small business loans

The Community Reinvestment Act requires large banks to report new small business loans. In 2019, reporting banks issued \$778.6 million in loans to Mississippi businesses with revenues of \$1 million or less. Total reported new lending to businesses through loans of \$100,000 or less was \$603.4 million, and total reported new lending to businesses through loans of \$1 million or less was \$1.9 billion. 

Ownership shares include equal and majority ownership


