


Establishments

Between March 2019 and March 2020, 5,882 New Mexico establishments opened and 5,277 closed, for a net increase of 605. Employment expanded at 11,446 and contracted at 11,606. Small businesses accounted for 5,853 openings and 5,256 closings.


Employment

Opening and expanding New Mexico establishments added 73,995 jobs, while closing and contracting establishments lost 67,488, for a net increase of 6,507 jobs. Small businesses contributed a net increase of 5,355 jobs, or 82.3 percent of that total.

Thousands of jobs





Small business loans

The Community Reinvestment Act requires large banks to report new small business loans. In 2019, reporting banks issued \$387.7 million in loans to New Mexico businesses with revenues of \$1 million or less. Total reported new lending to businesses through loans of \$100,000 or less was \$444.2 million, and total reported new lending to businesses through loans of \$1 million or less was \$976.1 million.



Small business exports

A total of 1,455 identified firms exported goods worth \$4.6 billion from New Mexico in 2019. Of those exporters, 1,210—or 83.2 percent—were small. Small firms exported goods worth \$2.2 billion, making up 47.6 percent of exports by identified firms.


