

#### **Business dynamics**


#### **Establishments**

Between March 2019 and March 2020, 10,912 Nevada establishments opened and 8,544 closed, for a net increase of 2,368. Employment expanded at 18,621 and contracted at 18,118. Small businesses accounted for 10,841 openings and 8,490 closings.


#### **Employment**

Opening and expanding Nevada establishments added 137,745 jobs, while closing and contracting establishments lost 122,474, for a net increase of 15,271 jobs. Small businesses gained 117,174 jobs and lost 99,536, for a net increase of 17,638 jobs.

#### Thousands of jobs



#### **Small business loans**

The Community Reinvestment Act requires large banks to report new small business loans. In 2019, reporting banks issued \$621.7 million in loans to Nevada businesses with revenues of \$1 million or less. Total reported new lending to businesses through loans of \$100,000 or less was \$910.1 million, and total reported new lending to businesses through loans of \$1 million or less was \$1.8 billion.



#### **Small business exports**

A total of 3,493 identified firms exported goods worth \$7.8 billion from Nevada in 2019. Of those exporters, 2,991—or 85.6 percent—were small. Small firms exported goods worth \$1.9 billion, making up 23.8 percent of exports by identified firms.


