About these profiles

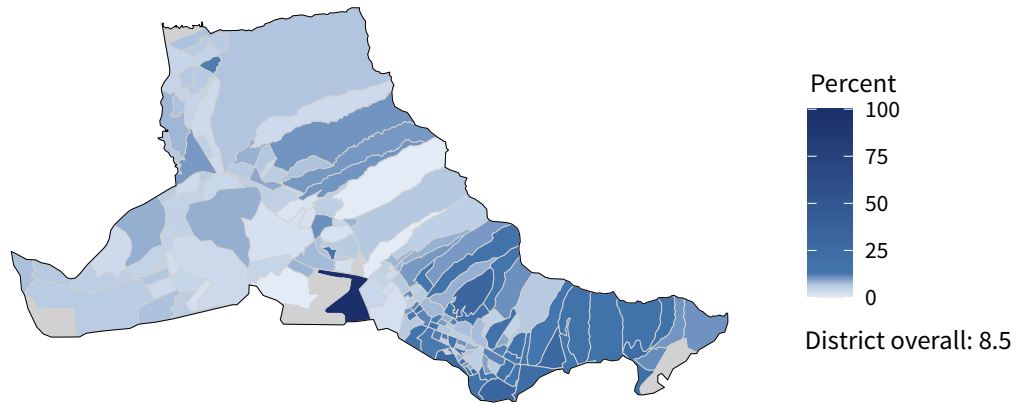

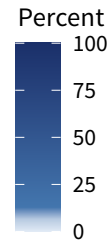
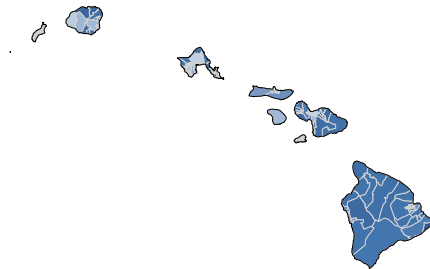
