### **About these profiles**

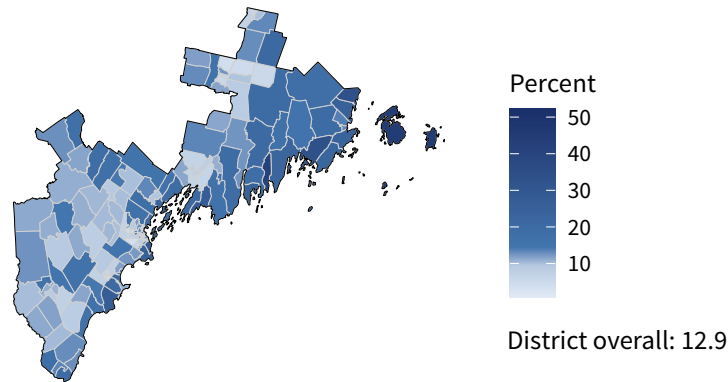

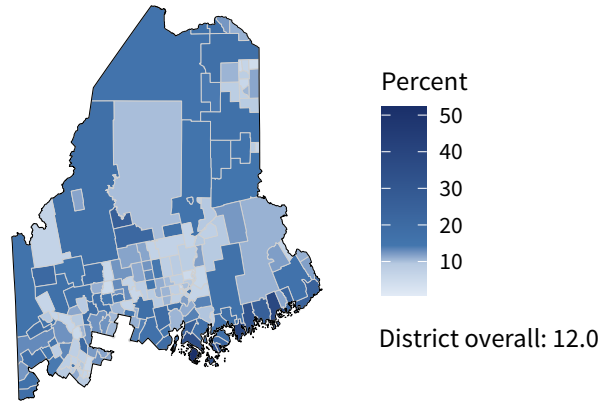
