


Employer and employment dynamics


Establishments

Between March 2023 and March 2024, 3,199 North Dakota establishments opened and 2,787 closed, for a net increase of 412. Employment expanded at 7,326 establishments and contracted at 6,221. Small businesses accounted for 2,940 openings and for 2,522 closings.

Employment

Opening and expanding North Dakota establishments added 36,555 jobs, while closing and contracting establishments lost 30,530, for a net increase of 6,025 jobs. Small businesses gained 29,523 jobs and lost 23,165, for a net increase of 6,358 jobs.



Small business loans

The Community Reinvestment Act requires large banks to report new small business loans. In 2023, reporting banks issued \$407.8 million in loans to North Dakota businesses with revenues of \$1 million or less. Total reported new lending to businesses through loans of \$1 million or less was \$1.1 billion. Total reported new lending to businesses through loans of \$100,000 or less was \$275.3 million.


Small business exports

A total of 1,745 identified firms exported goods worth \$8.4 billion from North Dakota in 2023. Of those exporters, 1,456—or 83.4 percent—were small. At \$2.0 billion, exports by small firms made up 23.6 percent of exports by identified firms.


